The challenges of document collaboration

- The need for advanced redaction capabilities, a comprehensive audit trail, seamless tracking of changes in realtime collaboration, and powerful version control capabilities with robust security
- Multiple file formats which caused formatting issues, errors, or loss of information as they were incompatible with the software used by collaborators
